RESOLUTION TO APPROVE THE POLICY ON ADDING NAMES TO THE VIRGINIA TECH MEMORIAL PYLONS

WHEREAS, Virginia Polytechnic Institute and State University is one of six Senior Military Colleges in the United States and is one of two to offer a Corps of Cadets embedded within a larger civilian university; and,

WHEREAS, the War Memorial Pylons illustrate Virginia Tech's core values of Brotherhood, Honor, Leadership, Sacrifice, Service, Loyalty, Duty, and Ut Prosim; and,

WHEREAS, the War Memorial Pylons are one of the most important and symbolic structures on campus and bear the names of Virginia Tech students and alumni who were killed defending our nation's freedom, beginning with those lost during World War I; and,

WHEREAS, members and graduates of the Virginia Tech Corps of Cadets have provided leadership in our nation's time of need since the Spanish American War to, more recently, Operations Iraqi and Enduring Freedom. And the valor of our alumni is legendary, with seven Medal of Honor recipients, and 22 recipients of the nation's second-highest award for valor, the Distinguished Service Cross or Navy Cross; and,

WHEREAS, the Virginia Tech Corps of Cadets is the keeper of the university's earliest traditions, to include being guardians of the War Memorial Pylons, and is evident in the solemn pylon dedication ceremonies conducted to honor our alumni who have made the ultimate sacrifice while serving in the armed forces;

NOW, THEREFORE, BE IT RESOLVED that the Board of Visitors of Virginia Polytechnic Institute and State University approves the Policy on Adding Names to the Virginia Tech Memorial Pylons to reaffirm the university's commitment to remember and respect the sacrifice of those who died and those affected by their loss, and to establish the criteria and procedures for the addition of individual names to be etched onto the Virginia Tech War Memorial Pylons;

AND, BE IT FURTHER RESOLVED that any future changes to the eligibility criteria must be approved by the Board of Visitors.

RECOMMENDATION:

That the policy on adding individual names to the Virginia Tech Memorial Pylons be approved.

1.0 Purpose

This policy establishes criteria and procedures for the addition of individual names to be etched on the Virginia Tech War Memorial Pylons. The Pylons are a memorial to Virginia Tech alumni who lived out the University's motto, "Ut Prosim" – That I May Serve, preserving in stone the names of those who made the ultimate sacrifice in military service to the United States.

2.0 Policy

The university will recognize and honor Virginia Tech alumni who are killed in the line of duty while serving in the United States military during war or during an official state of conflict through the commemorative addition of the individual's name to the Virginia Tech War Memorial Pylons. This policy reaffirms the university's commitment to remember and respect the sacrifice of those who died and those affected by their loss. To be considered for this honor, the service member must meet certain eligibility criteria. The Virginia Tech Commandant of Cadets is responsible for administering this policy, as well as for maintaining detailed procedures for both the implementation and management of the process of adding the names to the Pylons.

2.1 The Memorial Pylons

Each Memorial Pylon represents one of the eight core values of Virginia Tech as well as a specific war or state of conflict. At present, each core value is associated with the following war or conflict:

- a. UT PROSIM: WWII (1941-45), Desert Storm (1991) and Afghanistan/Iraq (2003-current)
- b. DUTY: WWII (1941-45)
- c. LOYALTY: WWII (1941-45)
- d. SERVICE: WWII (1941-45)
- e. BROTHERHOOD: WWI (1917-18) AND KOREA (1950-53)
- f. HONOR: WWII (1941-45) AND VIETNAM (1962-73)
- g. LEADERSHIP: WWII (1941-45)
- h. SACRIFICE: WWII (1941-45)

2.2 Eligibility

In order to be considered for the honor of having one's name inscribed on the Pylons, an individual must meet all of the following criteria:

a. Have been a graduate or a former student of Virginia Tech who was enrolled and attended classes for at least one year (two semesters or three quarters);

- b. Have made the ultimate sacrifice while serving in the line of duty for the United States military active duty, guard, or reserves. This includes individuals serving in both combat and training, in domestic or overseas environments; and
- c. Have given their life while the United States was involved in a war or official state of conflict, as designated by the United States Congress. Exceptions may be granted by the Commandant of Cadets for terrorist attacks or other incidents that occur outside of declared conflicts.

Once the Commandant of Cadets is notified that an individual is deceased, the Commandant's staff is responsible for confirming the person's eligibility.

Any changes proposed to the eligibility criteria must be approved by the Virginia Tech Board of Visitors.

3.0 Procedures

The Commandant of the Corps of Cadets is responsible for maintaining all processes and procedures for the addition of a name to the Virginia Tech Memorial Pylons. Upon approval, the Commandant and the Virginia Tech Corps of Cadets staff will work with the appropriate Virginia Tech entities, to include the Senior Associate Vice President for Alumni Relations and the Associate Vice President and Chief Facilities Officer, to coordinate the etching of the name as well as the dedication ceremony.

Significant changes to any process or procedure related to this policy will be authorized by the University President.
