President's Report in Full Board Meeting – June 5th, 2017:

We are setting up for a great VT21 class. We have a good bead on the shape of our first-year incoming class before summer melt. We are still assembling out transfer class, and the graduate student picture will evolve over the summer.

Key observations with respect to the incoming first-year class: We will meet all of our important enrollment goals. At the moment (before melt), those that have accepted our offers number more than 7,000 (fall enrollment target 6,365). Congratulations to the colleges and to enrollment management. We are up in every category and every college.

You recall that we had concerns over international enrollment. While the situation with graduate students is still in flux, we do have 542 international undergraduate acceptances. This is 14% greater than 2015, and 36% over our target. Keep in mind, though, that many of these students still need visas and we will have to watch melt carefully.

With respect to URM students, it looks like we will meet our milestone of 13% for the entering class. We could be higher depending on the makeup of the transfer population. This represents 17% growth in African American students since 2015, and 18% increase for Hispanic, Latino/Latina. We have a long way to go to reach our aspiration of 25% URM students in our incoming class in 2022, but we are on the path we presented to you last year.

We do not have complete numbers in the other underserved categories (low income and first generation). These will be available in the coming weeks.

His extensive community service includes serving as a director and officer of diverse non-profit and professional organizations, including Rotary, Navy League of the United States, Southeastern Admiralty Law Institute, Future of Hampton Roads, and Sorenson Institute for Political Leadership.

As Rector this past year, Jim has made the trip to Blacksburg several times a month to attend major events like the State of the University address, Commencement, and others, and to meet with every major constituent group on campus.

Dr. Tom Ryan was also appointed in 2013. He is an alumnus of the Class of 1968, earning a degree in biological sciences.
