Rector Long convened the meeting of committee chairs and explained that the purpose was to identify topics for the board's next information session in November and possibly beyond. The committee chairs developed the following list:

- 1. Annual Strategic Plan progress update. Additionally, this should have a forward-looking component building on the access and affordability discussion including aspirations, linking priorities more clearly to the SP.
- Annual Enrollment Management Report.
- 3. Future of Education discussion, part I progress of the work of the Task Force. This may be the first in a series of information session discussions culminating in a larger discussion at the board's August 2023 retreat. Subtopics include: what it will look like; residential model; experiential learning; instructional model (hybrid, in-person); what students want (may need a consultant or external speaker); research on the psychology of learning and how adults learn, and how we deliver instruction.

- 4. Discussion of Economic Development using a case study (e.g., Innovation Campus) and—importantly—including industry partners. This might also include a briefing on recent grants awarded
- 5. IT Transformation discussion of substantive matters. If substantive discussion is premature, this might be postponed until March.
- 6. Update on Freedom of Speech/Academic Freedom working group could occur at info session or during full board meeting.

Future topic – future of medical school partnership with Carilion

Note: Prior to each Board meeting, the IT dashboard will be updated and an Innovation Campus update report will be placed in the portal for the board's information. This enables the board to determine at what meetings they would like to have an in-depth presentation on specific aspects of those initiatives.
