**WHEREAS**, Ms. Dugan has demonstrated the value of her Virginia Tech education, applying her expertise globally as a highly respected and prominent leader in innovation and technology development, being hailed as one of the nation's most important leaders in this field; and

**WHEREAS**, Ms. Dugan has had a long, distinguished, and exemplary career that serves as a testament to her personal drive and skill as a leader, collaborator, and strategist, serving as the first female director of the Defense Advanced Research Projects Agency (DARPA), followed by senior executive roles at Google, Facebook, and Motorola where she led skunkworks labs focused on developing futuristic technologies; and

**WHEREAS**, Virginia Tech is very proud to recognize among its most esteemed alumni Nicholas D. Street, a member of the class of 1953 who received his bachelor of science degree from the Pamplin College of Business and has been a loyal and enthusiastic volunteer and supporter of the university; and

**WHEREAS**, an individual of integrity, humility, fearlessness and solid work ethic, Mr. Street values the influence of Virginia Tech in his life with its emphasis on the ideals of leadership, loyalty, service and Ut Prosim – *That I May Serve*. Mr. Street was a proud member of the Virginia Tech Corps of Cadets, where he gained the invaluable life traits of scholarship, service, and leadership; and

**WHEREAS**, following honorable service in the United States Air Force as a pilot with the aerial warfare branch, Nick Street applied his superior business acumen to become a servant leader in Southwest Virginia, garnering professional prestige throughout his long and distinguished career in the legal arena. He has served his Southwestern Virginia community as a prominent attorney with the Street Law Firm in addition to being the co-founder of The United Company, which has evolved from its origin of coal production to a base of diversified operations, including coal, oil and gas exploration services, investment management and real estate services; and

**WHEREAS**, Nick Street has had an extensive tenure of service and continued engagement at Virginia Tech, serving on the Class of '53 Reunion Committee, the Virginia Tech Athletic Fund Board of Directors, and the Corps Leadership and Military Science Committee, among other volunteer leadership roles; and
