**WHEREAS**, this investment will also support sustainability, diversity, and innovation by supporting the building of the Virginia Tech Innovation Campus Academic Building I; and

**WHEREAS**, Virginia Tech will appropriately acknowledge the connection of the Boeing Company to its newly founded Innovation Campus, and seeks to continue the Boeing Company's involvement in subsequent years;

**NOW, THEREFORE, BE IT RESOLVED** that in acknowledgement of the Boeing Company's generosity and in recognition of current and future benefits to the university, the newly built Innovation Campus auditorium will be known as the Boeing Auditorium for a period of 10 years to commence upon the date of building completion.
