WHEREAS, Mr. Jessee is vice president for Generating Assets for Appalachian Power Company and Wheeling Power and holds a B.S. in mechanical engineering from Virginia Tech; and

WHEREAS, Mr. Kreutzer is senior vice president and chief administrative officer for Ramaco Resources and holds a B.A. from Transylvania University and a Juris Doctor from Chase College of Law at Northern Kentucky University; and

WHEREAS, Mr. Wimmer is senior project engineer at Coronado Global at the Buchanan Operations and holds a B.S. in mechanical engineering from Virginia Tech and a M.S. in Mining & Minerals Engineering from Virginia Tech; and

WHEREAS, Mr. Elkins is vice president of mining at Appalachian Technical Services, Inc. who received an M.B.A. from King University, an M.S. in environmental engineering from Marshall University Graduate College, and a B.S. in mining engineering from Virginia Tech; and

WHEREAS, Mr. Mason is the principal of the George Mason Law Firm, PSC, in Lexington, Kentucky, has a B.A. and J.D. from the University of Kentucky, and is admitted to practice before the U.S. District Courts of Kentucky and Virginia, Southern District of West Virginia, U.S. Court of Appeals for the Fourth and Sixth Circuits, and the U.S. Supreme Court; and

WHEREAS, Dr. Ratliff is a sponsored programs consultant at Virginia Highlands Community College and interim vice president of instruction at Wytheville Community College who received an Ed.D. in education leadership from Liberty University, an M.B.A. from Morehead State University, a B.S. in business administration from Tusculum College, and an A.A.S. from Mountain Empire Community College.
